**ORDER :**

Thiru K.Kumaresan, Junior Assistant was initially appointed as Data Entry Operator in the O/of the Commissioner of Police, Chennai City Police, under compassionate grounds. He was reported for duty as Data Entry Operator on 01.03.2006 FN.

2. His service as Data Entry Operator has been regularized with effect from 01.03.2006 FN and probation declared with effect from 01.05.2009 FN as per G.O.Ms.No.220 Home (Pol.XV) Department, dated 18.02.2016.

3. Subsequently, he was appointed as Junior Assistant on transfer of service on 29.08.2018 FN at CPO in the reference 2<sup>nd</sup> to 4<sup>th</sup> cited above and posted to Office of the Joint Commissioner of Police, South Zone. He was reported for duty on transfer of service in this office as Junior Assistant on 30.08.2018 FN.

4. As per Chief Office circular memo 6<sup>th</sup> read above, the post of Junior Assistnt may be regularized by the appointing authority as per the G.O.Ms No.80. Lbour and Employment (Q1) Department dated 02.03.2016, as the post of Data Entry Operator comes under Tamil Nadu General Subordinate Service and the post of Junior Assistant comes under Tamil Nadu Ministerial Service.

5. As per the G.O.Ms.No.80, Labour and Employment (Q1) Department dated 02.03.2016, the post of Junior Assistant /Typist can be regularized by the appointing authority concerned.

6. Therefore, Thiru K.Kumaresan, Junior Assistant, Office of the Joint Commissioner of Police, South Zone has fully satisfied all the terms and conditions without any relaxation relevant to the appointment on Compassionate Grounds. Hence it is hereby ordered that his services are regularized with effect from 29.08.2018 FN (i.e) from the date of appointment on transfer of service, as Junior Assistant.
