The Principal District Judge, Kanniyakumari @ Nagercoil, has forwarded the proposal for regularisation of service, in respect of Thiru.Sajith J.K.Castro S/o. Late C.Jeya Kumaran (formerly Bench Clerk Grade-II, Sub Court, Kuzhithurai, expired while in service on 04.05.2018), who has been appointed temporarily as Junior Assistant on compassionate grounds in the II Additional District Munsif Court, Kuzhithurai, for obtaining the concurrence

of Tamil Nadu Public Service Commission.

The Government in G.O. 3<sup>rd</sup> cited have issued orders and guidelines to be followed for facilitating speedy regularisation of service of employees who were appointed on Compassionate ground during the period from 02.02.2016 to 31.12.2019 and said G.O. has been communicated to all the Appointing Authorities/Principal District Judges/District Judges/Unit Heads vide High Court's Official Memorandum 4<sup>th</sup> cited.
